## What Fits

A plain text advertisement can include about 40 words in an inch, not including contact information. An ad with a small picture can fit about 25 words. Go up to two inches to incorporate more text and larger or additional pictures. As a general rule of thumb, a two-inch ad can have about 85 words, or one picture and 60 words.
